# RESOLUTION TO LIFT SUSPENSION OF IN-PERSON ACTIVITY IN THE SCA AS OF JUNE 1ST, 2021

From: The Board of Directors, and the offices of the Society Seneschal, and President

On March 23, 2021, the Board of Directors passed the following:

#### Resolution to Lift Suspension of In-Person Activity in the SCA as of June 1st, 2021

- I. Whereas the challenge created by the COVID-19 Global Pandemic demanded heightened safety standards which led to a suspension of in-person activity in North America by the SCA Board of Directors;
- II. Whereas the crisis of the Pandemic is being addressed through a combination of social policy, as well as scientific and medical advancements:
- III. Whereas the SCA Board of Directors continues to prioritize the health and well-being of the membership and participants of the SCA; and
- IV. Whereas the directed suspension of in-person events in North America expires after May 31st, 2021; now, therefore, be it
- V. *Resolved*, that the SCA Board of Directors lifts the suspension of in-person activity in North America, effective June 1, 2021, provided adherence to the items in this resolution;
- VI. *Resolved*, that all attendees in North America must follow all province, territory, state, and local health guidelines at SCA events. In addition, at all North American SCA events:
  - A. Masks that fully cover the mouth and nose must be worn by all attendees over the age of 4 at all times and during all activities except for eating and drinking;
  - B. Court, bardic circles, or any activity that involves voice projection shall also require that masks be worn at all times. Sound amplification devices are highly recommended;
  - C. No day board, water bearing, or food of any kind shall be provided by event staff or attendees to other attendees. All attendees must provide their own food and beverages;
  - D. While consuming food or beverages, attendees are required to remain stationary and follow social distancing rules;
  - E. No overnight camping shall be allowed;
  - F. All events shall be held outdoors;
  - G. There shall be a maximum of 150 people at any event; and,
  - H. All events shall require preregistration.
- VII. *Resolved*, that the SCA Board of Directors mandates applicable Kingdoms who have determined that it is safe to host in-person events before June 1st, 2021 or who propose any deviation from the above restrictions to request a variance from the Society Seneschal in order to hold the proposed event. The Society Seneschal shall have the authority to grant or deny these requests. These requests will be reviewed by the Board using the same review method used for variances to Corpora;
- VIII. *Resolved*, that small local gatherings including, but not limited to: guild meetings, officer meetings, and local martial activities including archery and thrown weapons shall remain at the discretion of the Crown and Kingdom Seneschal, in accordance with province, territory, state, and local health guidelines. Virtual events as alternatives continue to be a viable option;
- IX. Resolved, that enforcement of this resolution will be handled by the Society Seneschal and President of SCA Inc.; and,
- X. *Resolved*, that the SCA Board of Directors commends the hard-working officers, royalty, membership, and participants who have allowed the SCA to continue to flourish virtually as we lift this suspension and transition forward in a manner consistent with recommended health and safety standards.

The President and the Society Seneschal have been given the responsibility of implementing the resumption of events within the rules above and adjusting the strictures as needed with Board approval.

As per item (H) in the Resolution, SCA, Inc. has available the Event Module for the mandatory pre-registration process. All kingdoms are encouraged to utilize this tool. More information will be forthcoming from the SCA Accounting Specialist, Mazelle Attiya. If you would like to contact her about this available option, she can be reached at treasurer@sca.org.

#### THE CROWN OF NORTHSHIELD'S LETTER ON SCHEDULING THE NEXT CROWN TOURNEY

Greetings Northshield,

We know that everyone has been anxious to hear details about the Crown Tournament and the SCA reopening. Hopefully by now you have seen the official reopening notice from the BOD. If not please see: <u>BOD Resolution to Lift Suspension of In-Person Activity in the SCA as of June 1st, 2021</u>

We have received a variance from the BOD to hold our Crown Tournament as scheduled in June and to allow the Northshield Law that one member must have the ability to cross the border to be waived for this crown. Coronation is planned to be held, as normal, in September.

We feel it is important to get the kingdom back to a normal royal rotation as soon as possible, which is the reason we are not waiting longer to hold crown.

We hope that Our Heirs will have the task of bringing SCA back to in person activities. We foresee this will be challenging due to the pandemic not being completely eradicated and various people will be hesitant to attend events in person for a myriad of reasons. We may have to live in a hybrid SCA world for a while.

At this time, it is hard to say what our summer will look like. We plan to step down in September. We hope that much of Northshield will be able to attend the coronation of our Heirs. We would also like to give our Heirs the opportunity to plan a Coronation and have time to plan their reign. Hopefully, the pandemic will have improved by September and US States and Canada will have less restrictions. We would also like to be able to attend some events in person. We have not forgotten the people on vigil and will be contacting them about their peerage ceremony plans. We feel a slow reopening will give everyone time to readjust back to in person events.

#### Here are the current crown plans:

Crown will be held at Duchess Mary and Duke Lars's home. The Crown bid Duchess Mary submitted had an alternative option to host it at their home. Due to the event size limitations from the state of MN, holding the event at Lord of Light is cost prohibitive.

At this time, the border is closed and our combatant in Canada while thoroughly acceptable to the Crown will most likely be unable to attend. We hope that Canadian combatant can join us, but if they cannot we will be moving forward with the tournament. While the border being closed has never happened before it is not the first time combatants have not been able to compete due to forces outside of our control. Deciding this has been very difficult for us. Our Canadian groups are very important and they are integral to Northshield. We have no control over the border situation nor do have any insight to predict what the governments will do.

Attendance to Crown will be limited to Combatants, Consorts and one attendant per couple. The rest of the attendance spots will be reserved for essential officers and event staff. Pre-registration will be required.

We wish to have as safe and healthy an event as possible. We will abide by local and state pandemic regulations, as well as the SCA rules from the Resolution to Lift Suspension of In-Person Activity in the SCA as of June 1st, 2021

# RESOLUTION TO FURTHER LIFT SUSPENSION OF IN-PERSON ACTIVITY IN THE SCA AS OF JULY 1, 2021

From the Board of Directors and the offices of the Society Seneschal, and President.

On May 25, 2021, the Board of Directors passed the following:

#### Resolution to Further Lift Suspension of In-Person Activity in the SCA as of July 1st, 2021

- I. Whereas the challenge created by the COVID-19 Global Pandemic demanded heightened safety standards which led to a suspension of in-person activity and a subsequent partial lifting of that suspension in North America by the SCA Board of Directors;
- II. Whereas the crisis of the Pandemic is being addressed through a combination of social policy, as well as scientific and medical advancements:
- III. Whereas the SCA Board of Directors continues to prioritize the health and well-being of the membership and participants of the SCA; and
- IV. Whereas the directed suspension of in-person events in North America expires after May 31st, 2021, and the previous partial lifting of said suspension takes effect on June 1, 2021; now, therefore, be it
- V. *Resolved*, that the SCA Board of Directors further lifts the suspension of in-person activity in North America, effective July 1, 2021 provided adherence to the items in this resolution;
- VI. *Resolved*, that all attendees in North America must follow all province, territory, state, and local health guidelines at SCA events. In addition, at all North American SCA events:
- A. Kingdoms may require the use of masks at their events;
- B. The SCA may not provide shared drinking containers or any food served in a buffet-style. Attendees who accept shared drinking containers or buffet-style food from other attendees do so at their own risk. Feast will not be allowed at this time; and
- C. All events shall require preregistration.
- VII. *Resolved*, that the SCA Board of Directors mandates any Kingdoms who propose any deviation from the above restrictions to request a variance from the Society Seneschal in order to hold the proposed event. The Society Seneschal shall have the authority to grant or deny these requests. These requests will be reviewed by the Board using the same review method used for variances to Corpora;
- VIII. Resolved, that enforcement of this resolution will be handled by the Society Seneschal and President of SCA Inc.; and,
- IX. *Resolved*, that the SCA Board of Directors commends the hard-working officers, royalty, membership, and participants who have allowed the SCA to continue to flourish virtually as we lift this suspension and transition forward in a manner consistent with recommended health and safety standards.
- The President and the Society Seneschal have been given the responsibility of implementing the resumption of events within the rules above and adjusting the strictures as needed with Board approval.

As per item (C) in the Resolution, SCA, Inc. has available the Event Module for the mandatory pre-registration process. All kingdoms are encouraged to utilize this tool. # FROM THE SOCIETY SENESCHAL: RE: RESOLUTION TO FURTHER LIFT SUSPENSION OF IN-PERSON ACTIVITY IN THE SCA AS OF 7-1-2021

MAY 28, 2021 Greetings to the SCA:

In April of this year, the Board of Directors of the SCA, Inc. issued a proclamation allowing in-person events to resume in North America as of June 1, 2021, subject to any federal, state, provincial, or local government health restrictions, and subject to restrictions imposed by the Board to try to ensure the safety of our participants, given conditions of the pandemic at the time. It was stated then that these restrictions would be revisited as appropriate.

At their May 25, 2021 conference call meeting, the Board of Directors of the SCA, Inc. discussed the latest guidance from the CDC, as well as current trends in the United States in particular with regard to the increasing availability of COVID vaccinations and the decreasing incidence of illness and hospitalizations in the United States. The Board then decided to loosen many of the SCA-imposed restrictions effective July 1, 2021. The attached proclamation spells out the requirements for in-person events going forward from that July 1 date.

The Board further took the following action:

Motion by Dale Fong-Frederick to approve the following language, and require that it appear on all event notices, flyers, online announcements, and advertisements, as well as being posted in multiple locations, including Troll [Registration], at all events:

Although the SCA complies with all applicable laws to ensure the health and safety of our event participants, we cannot eliminate the risk of exposure to infectious diseases during in-person events. By participating in the in-person events of the SCA, you acknowledge and accept the potential risks. You agree to take any additional steps to protect your own health and safety and those under your control as you believe to be necessary.

Seconded by Gigi Coulson. Opposed: None. Motion carried.

This language will be required to appear on all event notices, flyers, online announcements, and advertisements, as well as being posted in multiple locations at any and all SCA-sponsored functions going forward. # A few important notes:

- 1. During the month of June, all current restrictions including mask requirements and the 150-person attendance limit remain in effect. The new proclamation does not take effect until July 1.
- 2. As always, any and all federal, state, provincial, and local health rules and restrictions must be followed. If your local government does not allow gatherings above a certain size, or requires masks, those restrictions of course must be enforced.
- 3. Individual kingdoms are always allowed to impose more restrictions than those imposed by the SCA, Inc. No kingdom is required to begin holding in-person events if the Crown and Kingdom Seneschal do not believe it is safe yet; a kingdom may continue to require face coverings, impose size limits on events, or prohibit overnight camping if it wishes. The President, Society Seneschal, and Board will support kingdoms in resuming events in the way that seems safest for them. - 4. The SCA has always been built on the ideals of chivalry and courtesy. We expect that people will continue to display these values at all times, and respect individuals' personal choices regarding their own health and safety.

The Society Seneschal and the President will continue to work with Kingdom Seneschals to implement the SCA's return to live events in a safe and responsible manner. We appreciate everyone's patience and understanding as we move forward.

Would you be interested in hosting a small event later this summer? We hope to see more activities on the line of Nordleigh's tournament event: a small, straightforward, outdoor gathering of just a few hours. Now is the perfect time to try out event organization on a small scale.

We are also looking ahead to Wishes & Waiting, the hybrid event that will take the place of Warriors & Warlords this year. It will combine online court and classes with the possibility of in-person martial practices and tournaments and, if desired, local in-person gatherings. Watch warriors and warlords org for updates!
